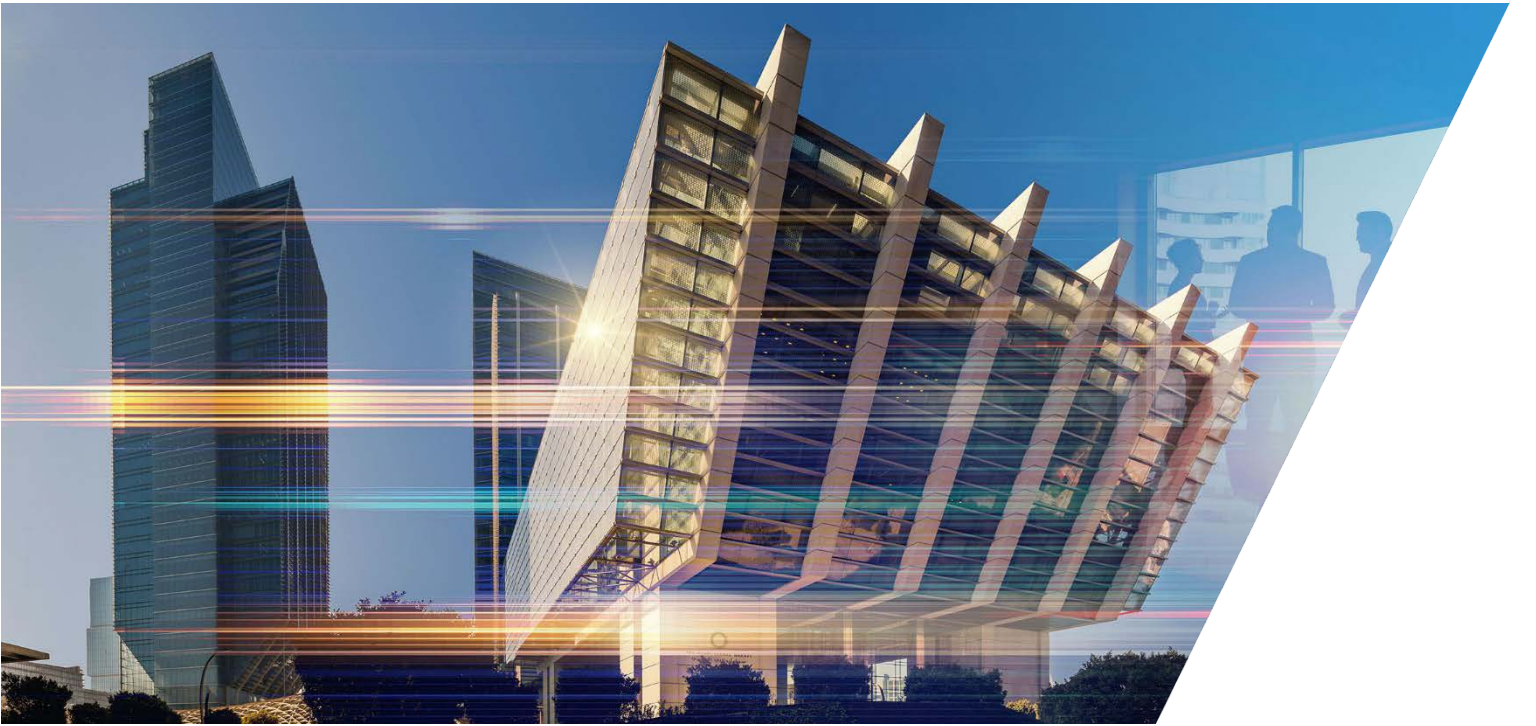

	Note: <ul style="list-style-type: none"> • <i>No refunds for settlement.</i> • <i>Filing fees include all case management conferences.</i> • <i>Filing fee for claims and counterclaims includes a half day hearing.</i> • <i>Claims and counterclaims that exceed a half day hearing are subject to an additional fee of USD 250 for each subsequent half day.</i> • <i>Where a claim or counterclaim is amended, the party making the amendment shall pay any difference if a higher fee would have been payable at the time the claim or counterclaim was commenced.</i>

Court of Appeal and Commercial and Civil Division	<p>USD 500 for all applications without a hearing or lasting no more than 2 hours' hearing time (half day rate)</p> <p>USD 1,000 for all applications exceeding 2 hours but lasting no more than 1 day (full day rate)</p>
Employment Division	<p>USD 250 for all applications without a hearing or lasting no more than 2 hours' hearing time (half day rate)</p> <p>USD 500 for all applications exceeding 2 hours but lasting no more than 1 day (full day rate)</p>
Small Claims Division	<p>USD 100 for applications for default judgment</p> <p>USD 250 for all other applications without a hearing or lasting no more than 2 hours' hearing time (half day rate)</p> <p>USD 500 for all applications exceeding 2 hours but lasting no more than 1 day (full day rate)</p>

The second hearing fee will be payable by the party that requested the hearing be vacated unless the Court orders otherwise.</i>

Application for deputisation of other ADGM Courts judgments to the judicial authorities of the Emirate and other Member Emirates	USD 200
Application for registration of recognised Court's judgment	USD 2,500
Application for certified copy of judgment or order	USD 100 (Commercial and Civil Division) USD 50 (Small Claims Division, except for order for default judgment or judgment by default) No filing fee for an application for certified copy of order for default judgment or judgment by default in the Small Claims Division
Enforcement of arbitration award	USD 2,500

BILLS OF COSTS AND DETAILED ASSESSMENTS	
Fee	5% of the amount claimed upon filing a Bill of Costs An additional amount of 2.5% is payable at the conclusion of a detailed assessment by the party requesting the detailed assessment if the difference between the provisional assessment and the detailed costs assessment is 15% or less USD 300 for the issuing of a default costs certificate
	Note: <i>Parties are entitled to a 50% reimbursement of the fee if they settle in full and advise the Court within 21 days of the date set for the detailed assessment.</i>
